Carbon Emissions Reduction Target

Westfield Medical Ltd. has established the above figures as our current baseline. Based on this data, we are targeting a 10% reduction in carbon emissions by 2028, equivalent to an average reduction of approximately 2.5% per year from our 2023 baseline.

Continual Improvement and Current Projects

In Q4 2024, Westfield Medical Ltd. installed solar panels on the roof of our manufacturing facility. This investment enables us to generate renewable electricity on-site and export surplus energy back to the National Grid.

In addition, we have embedded corporate objectives relating to waste management, monitoring, and reduction at the highest level of our organisation. These objectives formalise our commitment to continuous improvement and minimisation of waste across our operations.

Other ongoing initiatives include:

- Recycling of transport packaging.
- Promoting site-wide awareness of potential environmental impacts.
- Supporting Sterimed Infection Control in initiatives aligned with reducing environmental footprint.

Together, these measures demonstrate our commitment to reducing our carbon footprint and working towards achieving net zero by 2050, in line with UK government policy.

Future Projects

Westfield Medical Ltd. will complete a comprehensive carbon footprint calculation during calendar year 2025 for FY2024/25 (1st July 2024 – 30th June 2025). Upon completion, this document will be updated to reflect the new data, revised targets, and any additional carbon reduction measures.
